Dear colleagues,

we downloaded the file "cdda-IT-200403" to verify and update the current CDDA data set, as requested by the revised cover letter posted on the EIONET portal on 17 March 2004.

We are surprised that the file doesn't contains all the information we delivered in 2003. In fact, on 21 March 2003 we made a first release of the following documents:

- an Access file with Italian sitecode, Italian designation type, name, size, NUTs classification, institution year and remarks on updating;
- shape files with digitised boundaries.

On 19 May 2003 we made a second release with the final version of the Italian CDDA 2003 (file "CDDA-IT-200305.mdb") including habitat types provided for protected areas larger than 1.000 hectares, relations between sites, IUCN classification, altitude pertaining to each protected area, geographical coordinates.

We notified by letters both the releases (Prot. n.6603 of 28.03.2003 and Prot. n.10447 of 22.05.2003), uploading the documents in the Italian data repository of ElOnet at the following address:
